## **Course Outlines/Syllabus**

#### **Course Description:**

Qigong Sensory Treatment (QST) is a touch-based intervention involving daily parent implementation and guidance from a QST Certified Trainer. QST is based on Chinese medicine principles and was developed through rigorous studies. The QST research indicates that children with all levels of autism benefit from the QST intervention.

This six-month Qigong Sensory Treatment-Certified Trainer (QST-CT) online course is designed to train and certify professionals experienced in working with autistic children in the implementation of the Qigong Sensory Treatment (QST) intervention. The course starts with a five-week e-learning *Education Course* (asynchronous self-paced modules and a weekly live virtual class, estimated at 10-12 hours of studying each week). Upon successful completion of the *Education Course*, students will continue to the *Clinical Supervision Course*, a five-month treatment practicum with remote supervision and online learning components, in which each student will work with one autistic child and their family (in-person).

The five-week *Education Course* includes online modules covering theoretical and practical aspects of the QST intervention. During the five-month *Clinical Supervision Course*, students will provide a minimum of 20 hands-on QST treatments to the child while working together with the parents/caregivers. Coaching strategies for supporting the family's daily massage with their child will be taught and practiced. Students will be supervised by a QST Master Trainer via online platforms. Students will post their written treatment summaries to an online forum after each treatment and will receive feedback from their Master Trainer. Two live (virtual) supervised sessions and two videotaped sessions will be required. In addition, there will be two required live virtual case conferences, in which students will present their case studies. At the end of the five-month clinical practicum, students will conduct post-testing and an exit interview with their family, analyze changes, and present their complete case studies.

Upon successful completion of the *Education* and *Clinical Supervision* courses, the Qigong Sensory Training Institute will award each graduate a certificate as a Qigong Sensory Treatment Certified Trainer, and a total of 80 continuing education hours.

This course offers an option to earn **three graduate credits** through Trinity Washington University (requires separate registration and an additional \$375 fee, paid to Trinity Washington University directly). Please contact Orit Tal-Atzili at orit@qsti.org if interested.

#### **Instructional methodologies:**

Assigned readings, Self-paced PowerPoint presentations, online forum discussions, weekly virtual live classes, demonstrations, hands-on practices, student presentations, weekly quizzes, written and practicum final exams, supervised practicum, and reflective coaching.

#### **Prerequisites:**

- 1. Applicants should have at least two years of professional or paraprofessional experience working with autistic children or be a parent of an autistic child.
- 2. Applicants should be in good health, energetic, and have no physical limitations.

#### **Course Objectives and Expectations:**

To graduate from this course, students will be required to demonstrate proficiency in:

- Describing the research evidence that supports the effectiveness of the QST intervention in treating autistic children
- Explaining key concepts in Chinese medicine as applied to the QST intervention
- Describing what is Qigong, and the purpose and methods of Qigong Sensory Treatment
- Explaining autism from the Chinese medicine perspective, focusing on sensory abnormalities as a core deficit in autism and how QST can successfully address these abnormalities
- Describing the healing process with QST what changes are expected?
- Demonstrating proficiency in the application of the QST intervention
- Effectively training and providing ongoing QST coaching and consultation to parents/caregivers
- Using Qigong Sensory Treatment to treat children hands-on in collaboration with parents
- Coaching parents in attunement- how to interpret their child's responses, individualize, and adjust treatment techniques when giving the QST massage
- Conducting pre- and post-intervention evaluations to develop the child's QST profile and course of treatment, and assess and present changes in sensory processing, self-regulation, development, and parenting stress
- Students who successfully complete all course requirements will earn a certificate of a "Qigong Sensory Treatment Certified Trainer (QST-CT)"

#### Evaluation Methods/Requirements for certification as a "Qigong Sensory Treatment Certified Trainer (QST-CT)"

- Passing weekly quizzes (related to the week's materials)
- Passing practical and written final exams
- Completing a minimum of 20 treatment sessions with an autistic child and their family, including submission of a SOAP note after each treatment for Master Trainer's feedback, implementation of feedback, and a minimum of 2 live supervision sessions (via video platform) and 2 videotaped sessions
- Receiving a recommendation from the supervising Master Trainer that the student has demonstrated the knowledge and mastered the necessary skills to qualify as a Qigong Sensory Treatment Certified Trainer
- Demonstrating positive changes in the child, achieved through the use of QST (measured by pre-post tests)
- Participating in case presentations (oral presentation in each of the two online conference calls during the Clinical Supervision Course), including analysis and reflections on techniques, child's responses, progress, parents' fidelity, parent coaching, and overall treatment process

      - You have 120 minutes to complete your exam (the exam platform will record the time and close the exam after 120 minutes, but please also time yourself and stop on time)
      - Any discussions or consultations with others are NOT allowed
      - Any sharing, downloads, screenshots, saving on your device, or other duplication of the exam materials are NOT allowed (please avoid copyrights and confidentiality violations)
      - Students will sign a Final Written Exam Attestation Form to attest to compliance with these conditions.
    - Final Written Exam grading: A "Pass" grade is at least 86/101. Grades could be one of the following:
      - Pass (grade 96 or above) Eligible to continue to the Supervision Course without additional requirements.
      - Pass (grade 86-95) Required to resubmit answers to incomplete items on the exam, then eligible to continue to the Supervision Course.
      - Conditional Pass (grade 70-85): Required to resubmit answers to incomplete items on the exam for re-grading (needs to achieve a Pass grade of at least 86).
      - Fail (grade below 70): Allowed to answer incomplete questions via a closed-book 60-minute oral exam (virtual) with a Master Trainer (needs to achieve a Pass grade of at least 86).

# **Part 2: Five-Month Clinical Supervision Course**

#### Requirements:

- 1. Students will complete 24 sessions with one family with an autistic child (4 pre/post evaluation sessions, and 20 treatment sessions)
- 2. Students will participate in weekly online forums by:
  - a. Posting their treatment notes in the Discussion Forum within 24 hours of each treatment
  - b. Writing a comment/question/feedback/reflection to one other student's treatment note which already received feedback from a Master Trainer
  - c. Reviewing feedback provided by the supervising Master Trainer on treatment notes before the next treatment
  - d. Participating in educational forum discussions on the assigned readings by posting an original post (when applicable, see below)
- 3. Students will conduct two treatment sessions with live supervision through an audio-visual video platform (Tx's 2 & 12), as well as two videotaped treatment sessions (Tx's 8 & 18), and receive feedback from their Master Trainer
- 4. Students will participate in 2 live audio-video conferences and will present their case studies
- 5. At the end of the QST treatment, students will conduct post-intervention tests, create pre-post graphs to measure progress, conduct an exit interview, discuss progress, and provide recommendations to the family
- 6. Students will complete additional educational assignments (readings, reviewing slide presentations, etc.)

#### After meeting with the family:

- Complete the **Child's QST Profile** based on SSC or ATSC, intake, and the child's observation. email the completed form to your supervising Master Trainer.
- Forum: In your own thread, discuss your child's QST profile and expectations for initial treatment/s (possible blocks, emptiness, touch, pain, numbness, expected responses)
- Review the Guidelines for writing an effective SOAP note (course manual p. 135-6)
- Watch the QST treatment demonstration video and review the example SOAP note for this Tx to prepare for writing effective Tx notes.

#### At the second pre-treatment session:

- Teach parents the 12 QST movements, using the 12-Movement Picture Chart
- Instruct parents to start QST with their child before your first treatment and to log daily on the **QST Daily Message Log** (link in Ed-week 5 in "Send training materials to the family")
